ADDRESS LABELS / BUSINESS CARDS / LETTERHEADS / LABELS / LOGOS:

All artwork and type will be proofed by you

Seven free proofs. Proofs that exceed seven, will be charged \$1.00 to completed order. (This also includes the past seven proofs sent).

Items are shipped by my vendor. Have correct address to which you would like the products to arrive at.

Labels and Logo designed are shipped by me (Christopher W. Paradis).

Logos are \$40 per logo design. Logos will be mailed on CD and Emailed to correct email address given. Formats will be in JPEG, GIF, and PDF. Business cards are printed on a glossy stock, unless told otherwise by you.

Reorders- you will not be recharged for artwork design. You may supply your own artwork for not cost.

It is strongly recommended that you back up your own work.

I am not liable for copyright materials. Make sure if they are your original artwork, that it is indeed yours.

PHOTO ENHANCING AND RETOUCHING:

All photos will be completed in digital final output only. Photos will be emailed to your correct e-mail address. Payment must be sent before photo retouching is completed. There is no guarantee that your photos can be enhanced to the best quality. Please always send a digital file of the photo if you are able to do so. Designers will get in touch with you if a certain photo cannot be enhanced. Simple photo retouching starts at a low price of \$15.00 and complex photos at \$35.00. Designer(s) will have the final decision on weather the photo is simple or complex. (visit website for details) There are no refunds on photo retouching. Please allow 48hrs for final output of photo enhancing.

WEBSITE DESIGN:

Please have all the information you would like to be posted the first time.

Have photos clean, and logos already designed.

Touch up photography or logo designs, an extra art charge might be applied.

You are able to change your type of web design plan after one year being hosted with me.

Payment must be completed before hosting your site.

Personal plan websites are \$50 dollars per page on setup. Plus a \$30 charge per page on changes. Hosting is \$25 a year. If I handle your finances, hosting will be \$60 a year.

Business plans are \$350 a year. No setup fee and no page charge on changes.

For all late payments, a \$20 reactivation fee will be applied. (This is prior the vendor).

Please be advised that my websites are quick, easy, accessible, nonconflicting to find your information clearly with time management in process. Very little animation, music files, or video files should remain out of your website in order to run at top quality. However, if you already have videos or music posted online I am able to create a link to those locations. I will not do online research for you (example: web page links to different sites). If you request links to be posted on your web site, and I did not create that certain page, a separate window will open up. This is NOT NEGOTIABLE. This is a federal law and subject to the copyright laws. If I am no longer able to host your site or design your site, please refer to the 1-800 number given to you upon sign up. Other designers may also be available to work on your site. Please be advised that hosting personal information on the world wide web could be a security risk. I am not liable for any personal problems or identity issues.
